- 2. Exchange of information on research, academic materials, academic and research journals, publications, and instructional materials;
- 3. Organizing of joint research projects, academic seminar, conferences and trainings, or other opportunities as appropriate;
- 4. Other activities mutually agreed upon by the two institutions.

The terms of particular programs and related activities implemented in this Memorandum of Understanding (MOU) will be mutually discussed and agreed upon in a separate agreement by both parties which will serve as implementing rules and regulations prior to its implementation. #### **Teacher Development**

- d. Undertake interchange in community immersion (extension works) among graduate students/faculty members through advocacies and community organizing.
