## Chapter 2

### General Provision

## Chapter 3

### Term of Cooperation

**Clause 3:** If both parties have no objection, the term of cooperation will extend for another **five** years when it is due.

**Clause 4:** A Memorandum of Understanding is an agreement in the serial form and will be valid from the date of joint signatures of both parties. This joint agreement will be expired as long as either party between the two sides requests to terminate certifying by an official requesting letter sending to another one.

**Chapter 4**  
**Scope of Cooperation**

**Clause 4:** Both parties will sign the MOU for the following aspects, but are not limited:

1. Exchange of undergraduate and/ or graduate students
2. Exchange of faculty members and/ or staff
3. Join research activities and publications
4. Participate in seminars and academic meetings, outreach activities and cultural exchange


**Chapter 5**
