**Article I.** The purpose of this Memorandum of Understanding is to promote the educational and academic cooperation between Buriram Rajabhat University, Thailand (herein referred to as BRU) and Tilak Maharashtra Vidyapeeth (herein referred to as TMV). BRU and TMV agree to try their best to achieve the following objectives:

- 1) Promoting institutional exchange by inviting faculty and staff to participate in joint research project;
- 2) Promoting the exchange of the essays, publications, theses, and information related to the research;
  - 3) Promoting student exchange programmes.

**Article II**. In accordance with the principle of mutual and equal benefit, international travel costs will be borne by the visiting scholars (students), unless provided by specific arrangements.

**Article III.** Based on this MoU, BRU and TMV agree to assist each other in drawing up and carrying out the concrete contents of the research project if they develop various education plans in different areas. Details of these plans will be set up in a separate addendum to this memorandum.

Article IV. The MoU will be valid for five years; it will be valid once it is signed by the official representatives of two institutes. If either party wants to terminate this agreement, written notice needs to be given to the other party six months before the termination of the agreement. However, the ongoing projects should be continued to the end and not be affected by the termination of the agreement.
